Jennifer Neumiller, Deputy Tax Director/Land Use Administrator, presented the following three (3) planning and zoning items to the board;

 Resolution to Amend- 24-02-01 Trilogy Legends LLC from Residential to Commercial. This parcel is located In the SE1/4 of Section 9 and SW1/4 of Section 10, T44N, R87W, Mercer County, North Dakota.

Frey moved to approve the resolution to amend 24-02-021, Trilogy Legends LLC from a residential to a commercial property. Bauman seconded. All voted aye. Motion carried.

Conditional Use-24-02-02- VB BTS II, LLC - "Vertical Bridge" --Communications Tower – NW4 Sec. 11, T142N, R88W. This is a 370' guyed
communications tower with a 10' lightning rod, along with support
equipment to be located within 100'x100' leased compound.

Frey moved to approve Conditional Use-24-02-02. Taylor seconded. All voted aye. Motion carried.

 Temp Use #630 issued to Casey Voigt for a scoria pit in 10 Acres of NW4 of Section 31, T143N, R88W of the 5<sup>th</sup> P.M. Mercer County ND. Active since 2016. Restrictions include work limited to daylight hours.

Bauman moved to approve the renewal of permit #630 for Casey Voigt. Taylor seconded. All voted aye. Motion carried.

Policy Committee Chairman, Gwyn Bosch presented the following policy committee recommendations:

Frey made a motion to accept the employee recommendations from the policy committee as presented. Bauman seconded. All voted aye. Motion carried.

Bauman made a motion to approve that all employees sign up for direct deposit by July 1, 2024. Frey seconded. All voted aye. Motion carried.

Bauman moved to approve the Mercer Highway Department annual bid letting for April  $3^{\rm rd}$  at 10:00 a.m. Frey seconded. All voted aye. Motion carried.

Frey moved to approve the following wording for the extension service ballot measure to read: As per N.D.C.C. 11-38-01.3, shall the governing body of Mercer County obtain an additional 2 mills for the County Extension above the 2 mill levy limitation set out in the N.D.C.C. Chapter 11-38-01.3 for a total of 4 mills? Yes, means you approve the County Extension mill levy to be raised from 2 mills to 4 mills. No, means you reject the measure and County Extension mill levy will remain at 2 mills. Folk seconded. All voted aye. Motion carried.

Frey moved to accept the resolution and payment of \$2 from the City of Zap for properties ZZ14489011006 and ZZ14489050001. Bauman seconded. All voted aye. Motion carried.

The Board members requested recommendations from the Youth Bureau Director Rachel Poitra before making a final decision on spending any opioid monies.

States Attorney Schwarz informed the commission that any policy change must have a first and second reading before being implemented. The first reading of policy 403 Paydays is set for March 6, 2024, at 9:45 a.m. Todd also approved of the rescinding of the Parks In-Lieu motion which was made at the last meeting. It was verified that purchase order numbers are required on expenses of \$1,000 or more countywide.

Portfolio updates were given.

The board recessed at 10:18 a.m.

The board reconvened at 10:35 a.m.

Jason Bohrer with the Lignite Energy Council gave an update and outlook of the lignite industry specific to North Dakota. This report covered economic impact, political actions in connection with the legislative process, EPA proposed rules and strategies that are being done to support the lignite industry.

The Special Assessment District Ordinance second reading was given by States Attorney Schwarz. Frey moved to approve the second reading of the special assessment district procedure/ordinance. Bauman seconded. All voted aye. Motion carried.

The board recessed at 11:07 a.m.

The board reconvened at 11:15 a.m.

States Attorney Schwarz addressed the board regarding the Farrington land request and advised the commission to deny this request. Legal counsel for the Farringtons and S&R Partners, LLP which are opposing this request spoke briefly regarding their cases. Frey recused himself from any motion due to the fact that his employer Interstate Engineering, is involved in this petition. Folk made a motion to deny the petition. Hearing no second. Motion failed. Bauman moved to table the petition. Taylor seconded. Bauman and Taylor voted aye. Folk and Wolf voted nay. Motion tied. The petition will be put on the next meeting agenda on March 6, 2024, at 10:00 a.m.

Tanya Wieler %Dakota Dynamics HR, briefed the commission regarding the process of interviewing the HR candidate.
