Voigt moved to approve the September 23, 2025 special meeting minutes as presented. Folk seconded. All voted aye. Motion carried.

Bauman moved to approve zoning case 25-09-01, Minnesota Power, 230-Kilovolt Transmission Line, .3-Mile-Long Line in Section 36, T141N, R88W of the 5th P.M. Mercer County, ND. Folk seconded. Bauman rescinded his motion.

Board discussed the possible purchase or lease of an additional motor grader for the county. Item was placed on the October 15, 2025 regular meeting agenda. The following 2026 Budget changes were requested: (1) Add another \$0.50 to County Road employee Rachel Grimm's bump up, and (2) Change general fund retirement share from \$695,000 to \$524,000. A Special Budget meeting will be held on Monday, October 6, 2025 at 8:00 a.m. in the commission board room. There being no further business the meeting was adjourned at 12:21 p.m. The next regular meeting is scheduled for Wednesday, October 15, 2025, at 8:00 a.m. in the boardroom of the Mercer County Government Center in Stanton, North Dakota.
